<p>眼睛： 万一接触，立即用大量的清水冲洗至少 15 分钟，翻起上下眼睑，直到化学的残留物消失为止，迅速就医。</p> <p>Eye Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.</p> <p>皮肤：万一接触，用大量水冲洗至少 15 分钟，同时除去污染的衣物和鞋子，迅速就医。</p> <p>Skin Remove contaminated clothes and rinse skin with plenty of water or shower for 15 minutes. Get medical aid.</p> <p>吸入：立即从暴露处移至空气清新处，如果呼吸困难给予输氧，立即就医。</p> <p>Inhalation Remove from exposure and move to fresh air immediately. <div>为防止电池材料泄露或释放采取的措施</div> <div>如果电池内部材料泄露，试验人员应立刻撤离试验区直到烟气消散。将通风设备打开吹散危险性气体。用抹布擦净试验区，清除溢出的液体，将泄露电池放进塑料袋中，然后放进钢制容器。避免皮肤和眼睛接触或吸入有害气体。</div> <div>Steps to be Taken in case Material is Released or Spilled</div> <div>If the battery material is released, remove personnel from area until fumes dissipate. Provide maximum ventilation to clear out hazardous gases. Wipe it up with a cloth, and dispose of it in a plastic bag and put into a steel can. The preferred response is to leave the area and allow the battery to cool and vapors to dissipate. Provide maximum ventilation. Avoid skin and eye contact or inhalation of vapors. Remove spilled liquid with absorbent and incinerate.</div> <div>废弃物处置方法</div> <div>建议将电池完全放电，消耗电池内部的锂金属，并且深埋于土壤中。</div> <div>Waste Disposal Method</div> <div>It is recommended to discharge the battery to the end, to use up the metal lithium inside the battery, and to bury the discharged battery in soil.</div>

Do not short circuit terminals, or over charge the battery, forced over-discharge, throw to fire.
